The purposes of this modification are the following:

A. To exercise FAR Clause 52.217-8; as a result the contract is revised to reflect the following:

1) Period of Performance

(a) The period of performance is extended by 4 months to January 25, 2012. Therefore, the period of performance is changed to read September 26, 2007 to January 25, 2012.

2) Ceiling Increase

(b) To increase the estimated ceiling \$2,324,722.35 \$207,485.51 \$2,532,207.86.

(c) This option is being exercised at the labor rates and the ceiling amount in the attached pricing schedule. The ceiling and rates for Option Year 3 are currently in effect until September 25, 2011. The labor rates and ceiling increase listed above and in the pricing schedule attached take effect on September 26, 2011.

B. To provide incremental funding.

(d) This task order is hereby incrementally funded from \$1,949,427.02 by \$150,000.00 to \$2,099,427.02.
