Mr. Clough was also informed of the NRC process of inspections and determination of inspection findings when apparent violations are identified. Mr. Clough agreed that a violation had occurred on Dec. 6, 2006 and July 7, 2008, when Warner Bros. used their portable density gauge in the state of Connecticut. He stated that he had called the state of Connecticut to ask what actions were required and was told that he needed to register the use of the gauge with the state and that no further requirements were applicable. The company owns one Troxler density gauge, Model 4640B, containing a single 8 mCi Cs-137 sealed source. Mr. Clough said that they had taken corrective actions to prevent recurrence by revising their procedure, training the authorized users, and marking the transport container and utilization log with bold letters "Not To Be Taken Out Of State." The RSO stated that they will contract any work in NRC jurisdiction to a company with a current NRC license. The RSO was informed of the apparent violation of 10 CFR 150.20, what the regulation requires, that they will be contacted for a formal exit meeting via telephone after the NRC had completed its determination process, that the NRC will consider the information gained in telephone conversations and the site visit (inspection) conducted by Craig Gordon, in making a determination regarding the results of the inspection.
