

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to provide incremental funding in the amount of \$25,000.00 thereby increasing the total obligations from \$642,445.00 to \$667,445.00 Accordingly the contract is modified as follows:

"The amount obligated by the Government with respect to this task order is \$667,445.00 of which \$621,201.07 represents the estimated reimbursable costs, and the amount of \$46,243.93 represents the fixed fee."

All other terms and conditions of the subject task order remain unchanged including the ceiling amount of \$736,124.00.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
