This refers to our recent internal review of your NRC Material License No. 21-18889-01 that resulted in the discovery that an authorization made to this license in Amendment No. 26, dated July 1, 2010, was an error.

We previously contacted you about this matter in a letter dated June 13, 2011, when we issued a Corrected Copy to Amendment No. 28.

We have now decided to issue Corrected Copies to Amendment Nos. 24, 25, 26 and 27, enclosed, for the sake of completeness and greater clarity.

The Corrected Copy to Amendment No. 24, originally dated January 28, 2008, corrects an amendment numbering discrepancy on page 1 of the license, which read as "Amendment No. 2." It should have read as "Amendment No. 24," which is how it reads now.

The Corrected Copy to Amendment No. 25, originally dated June 11, 2009, corrects an amendment numbering discrepancy on all three pages, which read as "Amendment No. 03." It should have read as "Amendment No. 25," which is how it reads now.

The Corrected Copy to Amendment No. 26, originally dated July 1, 2010, no longer lists Joann M. Leahy, M.D. as an authorized user for the use of materials permitted by 10 CFR 35.400 for manual brachytherapy. There were no other changes made to Amendment No. 26 so it now appears to be identical to Amendment No. 25, as only the sequential Amendment Number increased.

The Corrected Copy to Amendment No. 27, originally dated November 2, 2010, renewed your NRC license for a five year term. Again, the Corrected Copy no longer lists Joann M. Leahy, M.D. as an authorized user for the use of materials permitted by 10 CFR 35.400 for manual brachytherapy. The changes made to the license for its renewal are now the primary remaining changes, although I added the clarifying language "(with attachments)" to the listing of your application dated June 15, 2010, in Condition No. 15.

The Corrected Copy to Amendment No. 28 was transmitted to you on June 13, 2011. There was an error in the cover letter transmitting the Corrected Copy, in that the following paragraph was inadvertently missing:

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
