Mr. Torres,

I have reviewed the NRC Form 313A (AUT) submitted for Dr. Grant to request authorization for 35.392 and 35.394 uses, and I have found two typographical errors.

For his Supervised Work Experience from July 2007 to June 2009, the Supervising Individual is listed as Antonio Ballingit on license number 46-02546-03. This license number is incorrect. It should have been listed as license number 46-02645-03. Dr. Ballingit was our Chief of Nuclear Medicine during this time and was listed on our license from Amendment 66 issued in 2001 until our most recent license renewal (Amendment 85) issued earlier this year.

Additionally, for Dr. Grant's Supervised Work Experience from July 2009 to March 2011, the Supervising Individual is listed as Yang Kao on license number 46-02546-03. This license number is also incorrect. It should have also been listed as 46-02645-03. Dr. Kao was our Chief of Nuclear Medicine during that time and has been listed on our license since Amendment 81 issued in 2008. You will find that the current amendment request you are reviewing asks for removal of Dr. Kao from our license since he has transferred and is no longer working at Madigan.

I apologize for the confusion caused by the above errors. Please make these two administrative changes to Dr. Grant's NRC Form 313A (AUT) that was submitted with the amendment request letter dated July 26, 2011. If this email communication is not satisfactory to correct these errors, please let me know how I can go about getting them corrected. Additionally, if you require any additional information while processing this amendment request, please let me know as well. Thank you for your time regarding this matter.
