This request includes, but is not limited to, any contracts (including any task orders or modifications) with the Contractors; project bids submitted by the Contractors; correspondence with the Contractors; documents provided by the Contractors concerning their costs (such as invoices, wage records, receipts, or other documentation of costs); materials reflecting the Contractors' compliance with the Davis-Bacon Act; master schedules or Gantt charts relating to contracts with the Contractors; documents reflecting collective bargaining agreements, Service Contract Act findings, or requests for approval of overtime relating to the Contractors; budgets, daily logs, or daily job reports filed by the Contractors; and audits of the Contractors.



Under FOIA, the NRC is required to make a determination concerning this request within twenty (20) working days of receipt of this request. If you deny all or any part of this request, please cite each specific exemption you think justifies your withholding of information. Please also notify me of appeal procedures available under the law.
