Reference Task Order NRR-001 under Contract NRC-10-07-414.

The purpose of this modification is to (1) increase the task order ceiling to reflect changes in the secretaries, and (2) add incremental funding, as follows:

1. Increase the ceiling of Task Order NRR-001 by \$21,007.94, from \$2,000,832.77 to \$2,021,840.71.

An estimated price schedule showing the secretaries, the hourly rate, estimated labor hours, and amounts for Option Year Two, as well as the total task order ceiling, is attached.
