Waiver_Purpose: My work is part of an official Illinois Dept. of Transportation (IDOT) planning study intending to help protect the health and safety of construction contractors, the general public, and the environment. The project for which I am completing a hazardous materials assessment is located in the Lake Bluff, IL area at the

US 41/IL 176 interchange (it is an interchange reconstruction project). The site in question is at the southeast corner of this interchange.

Waiver_ExtentToExtractAnalyze: I am conducting a full regulatory document review of all properties on or adjacent to this project for the Illinois Department of Transportation (IDOT). A Preliminary Environmental Site Assessment (PESA) report will be submitted to IDOT based upon this review and subsequent investigations. This NRC request is concerned with a single property (described above).

Waiver_SpecificActivityQuals: I am the senior environmental professional in my field office working on a contract to the IDOT and am based in the Greater Chicago metropolitan area. The information will be part of an assessment of risk associated with a state infrastructure development project. My report will be the property of the Illinois Dept. of Transportation.

Waiver_ImpactPublicUnderstanding: Information reviewed from state and federal environmental protection agencies indicated potential NRC involvement at this site. Online searches turned up a previous FOIA request for this site within your agency (NRC) (FOIA/PA-97-388) perhaps indicating the presence of records pertaining to this site. I am required to review any releasable information to which you may have access.

Waiver_NatureOfPublic: This is a state infrastructure development project involving two highways (US 41 and IL 176) and the general public. This project is in or adjacent to the Village of Lake Bluff, Knollwood, Great Lakes Naval Training Center (Great Lakes), North Chicago, and Lake Forest in Lake County, Illinois.

Waiver_MeansOfDissemination: A report will be written for the IDOT describing any risks/liabilities that the State of Illinois may undertake in the completion of this transportation project. This planning information will be used in possible engineering and construction efforts for this interchange redesign project.

Waiver_FreeToPublicOrFee: Standard State of Illinois FOIA policy as it relates specifically to the internal documents of the Illinois Dept. of Transportation and preliminary design planning would pertain.
