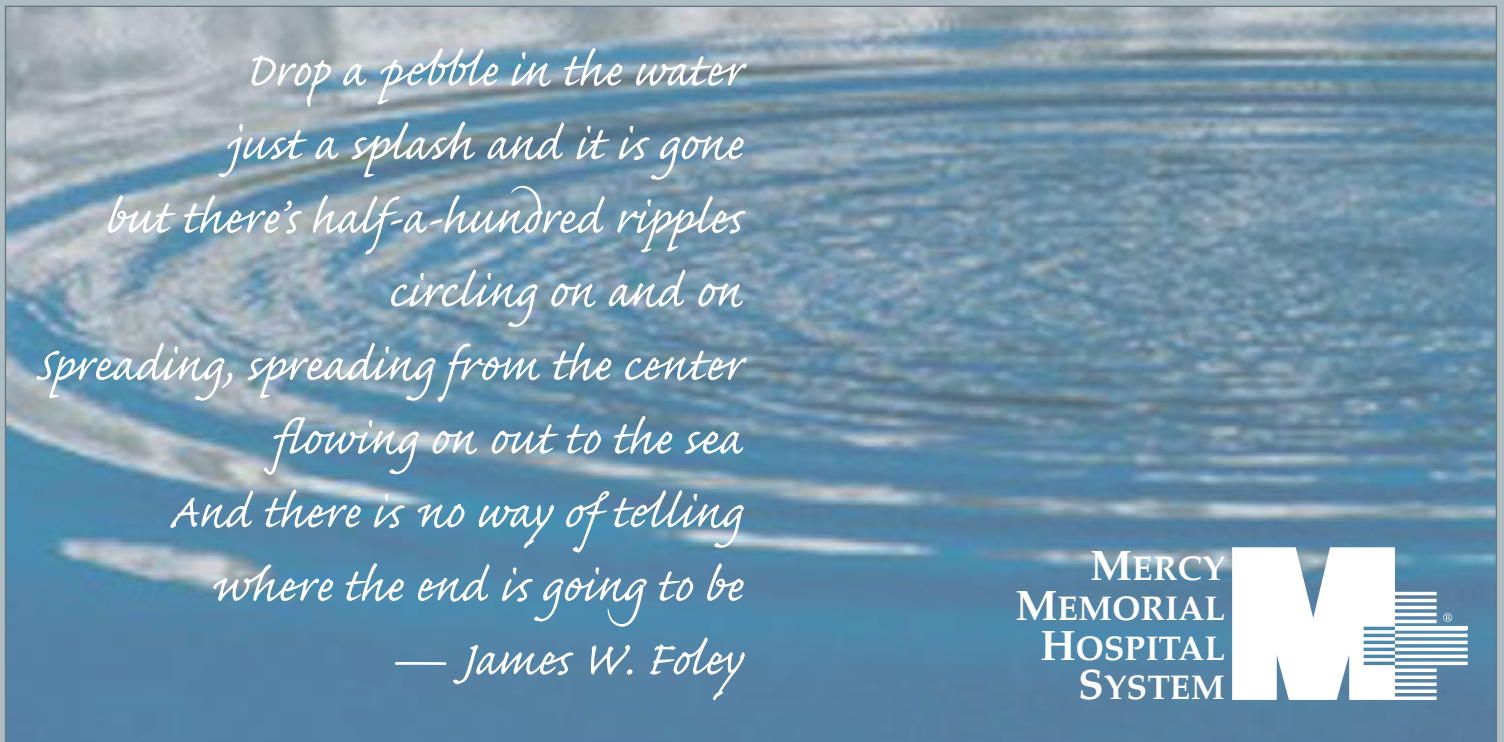

Over the span of a year, your community hospital has continued to provide outstanding healthcare services to the residents of Monroe County and surrounding areas while extending its reach via new facilities, services, programs and technology.

Excerpts from James W. Foley's poem "A Pebble" and the ripple effect the poem alludes to, illustrate the benefits our community will experience with the improvements at Mercy Memorial Hospital. Renovated facilities and added services are examples of MMHS' commitment to Monroe County. The changes will not only help the hospital thrive but also bring more jobs to the area. With an aggressive strategic plan in place, Mercy Memorial has continued to progress toward its goals.

The ripple effect of our enhancements reaches other facets of the hospital. Not only will we offer more services and improved facilities but also the best technology. Many of these diagnostic tools are already in use, serving members of the community by aiding physicians with their diagnoses. With our new 4D breast MRI, some women with suspicious mammograms can avoid a breast biopsy because the 4D MRI has a sensitivity near 100 percent for detecting invasive cancer as small as 3 millimeters. Early discovery saves lives and reduces the cost of treatment.

At MMHS, we are striving to improve the quality of care for our patients while also increasing our presence in the community with preventive care and health education. With participation in events like Health Check in conjunction with United Way, Women's Health Conference in partnership with the Family Medical Center of Michigan, Health Odyssey at the Monroe Senior Center, Put Yourself First Today! free mammograms made possible by a Komen grant, Diabetes Health Fair, prostate screenings, blood drives, and more, Mercy Memorial is reaching out to give back to the community.

Our changes would not be possible without the dedication and guidance of the Board of Trustees. We are sincerely thankful to the Guild for its continuous support and volunteers. As we continue our Capital Campaign, we want to express our gratitude to our generous donors. 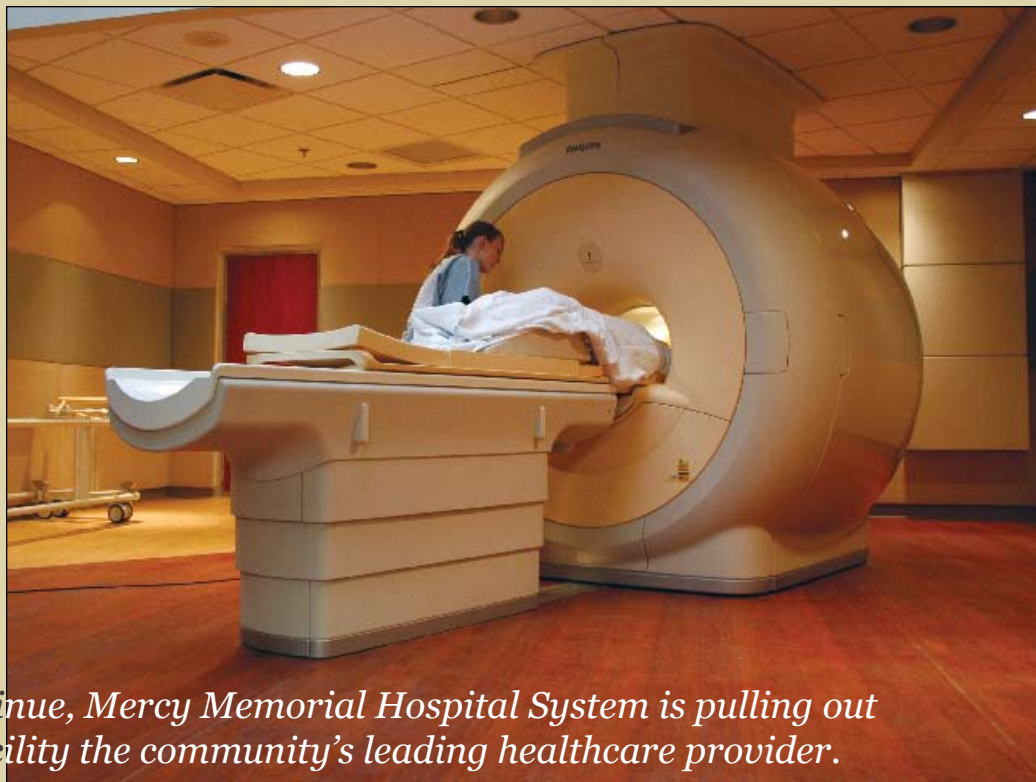

INSIDE THE NEW MMHS



As construction efforts continue, Mercy Memorial Hospital System is pulling out all the stops to make our facility the community's leading healthcare provider.

With its multi-million dollar renovation project well underway, Mercy Memorial Hospital System's campus is beginning to unveil some noticeable changes to the community.

From temporary entrances to blocked walls and hallways, it may seem that the most important changes have been on the appearance and accessibility of the building itself, but that's not the case. In fact, the most exciting improvements are happening inside with the introduction of state-of-the-art technology and cutting edge procedures.

3.0T Magnetic Resonance Imaging (pictured above)

— Patients and physicians in the area can now access one of the newest and highest-resolution magnetic resonance imaging scanners available: the fixed-base Philips Achieva 3.0T MRI system. The ultra-high-field MRI system enables faster and higher-resolution scans, resulting in superb image quality and potentially more accurate diagnoses. In addition, patients will appreciate its many comfort-related features.

Because of the level of detail it provides, the 3.0T MRI system can assist radiologists and physicians in the earlier diagnosis of a variety of medical conditions, including brain nervous system disorders, cardiovascular disease and organ disease. The wide patient opening, fast scan times and accurate scans that reduce the need for rescanning all contribute to a patient-friendly design.

4 Dimensional Breast MRI – Breast Magnetic Resonance Imaging is one of the safest and most comfortable imaging tests available. It uses magnetic fields without X-ray to obtain more than 3,000 images of the breasts. MRI is very helpful with difficult, suspicious or dense mammograms, especially in the 30-65-year-old age group. In recent years, breast MRI has become an important addition to ultrasound and mammography. With sensitivity near 100 percent for detecting invasive cancer as small as 3 mm, early discovery will save lives and reduce the cost of treatment.

MMHS is one of the few facilities in southeast Michigan using this advanced technology.

During an exam, the patient is on her stomach. Unlike mammography, MRI does not require the breasts to be compressed. Most exams last no longer than 25 minutes.

Breast MRI often is used for evaluating patients with dense breast tissue, breast pain, breast discharge, fibrocystic breast disease or with a personal or family history of breast cancer. It also is used in conjunction with mammography or ultrasound for clarification of inconclusive or abnormal findings. Breast MRI can also be used for the evaluation of implant rupture, radiation/chemotherapy treatments, and searching for primary breast cancer in patients with lymph node disease.

Most major health insurance agencies cover the cost of breast MRI when a patient has a physician order. If a patient's health plan requires the patient to have prior approval for this type of exam, the patient should obtain the necessary paperwork prior to the appointment.

When the exam is complete, a radiologist who specializes in breast MRI will review the images and prepare a report for the doctor. The doctor will then review it with the patient in the context of her overall health.

Philips Brilliance 64-Slice CT Scanner – A state-of-the-art multi-slice Computed Tomography (CT) scanner is now available at MMHS. The Brilliance 64-Slice CT scanner from Philips Medical Systems features advanced technology that produces split-second, high quality images, permitting doctors to see more anatomical detail in a fraction of the time needed for other tests. With this new CT scanner, Mercy Memorial Hospital System's radiologists and physicians will be able to more effectively detect and treat a range of life-threatening illnesses.

Complicated operation a success

Mercy Memorial Hospital System surgeon Michael Charboneau, D.O., recently performed a complex oncological surgical case at the hospital in collaboration with Harper Hospital Chief of Surgery and Oncology, Donald Weaver, M.D.

The patient had a large, retroperitoneal mass (a mass located behind the stomach). The location and size of the mass presented an increase in the complexity of the surgery.

Often, cases this complex are referred to tertiary centers in Detroit, Toledo or Ann Arbor.

“In my discussions with Dr. Weaver, the intent for both of us is to provide a more intensive service here for patients who have been diagnosed with cancer,” Dr. Charboneau said.

Dr. Charboneau has collaborated with Dr. Weaver and performed similar surgeries at Harper Hospital at the Detroit Medical Center.

Dr. Weaver is recognized nationally for his extensive experience in a variety of general and oncological surgery cases.

He works with general surgeons at community hospitals to help coordinate more complex surgical cases.

Dr. Weaver’s willingness to participate in these cases allows surgeries to be done closer to a patient’s home, thus improving access and continuity of care. Furthermore, keeping care close to home reduces travel for the patient and his or her family and can improve overall quality of patient care experience.

Dr. Charboneau said he plans to continue to work with Dr. Weaver to perform any surgery that can and should be done here at MMHS.

BEST IN DIGITAL MAMMOGRAPHY

Studies show digital technology is more accurate

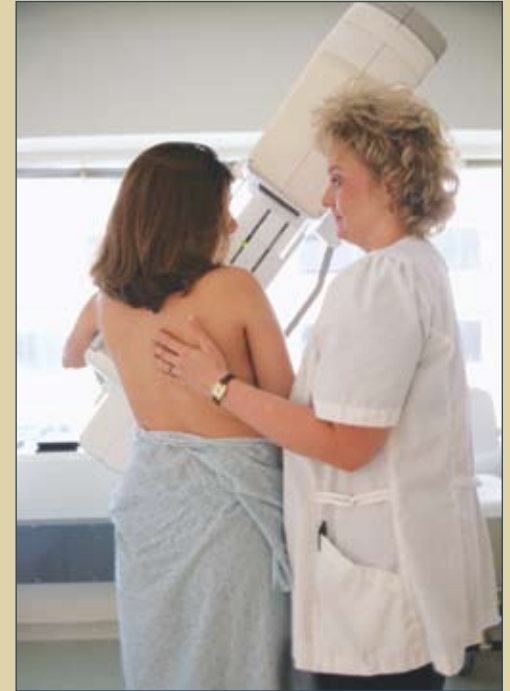
Mercy Memorial Hospital System is pleased to announce that the latest in digital mammography technology is available at the Women’s Health Center. With the installation of Fuji’s Computed Radiography for Mammography (FCRm) system, developed by FUJIFILM Medical Systems USA, Inc., Mercy Memorial Hospital is now one of the first breast imaging facilities in the U.S. to offer this digital mammography capability.

“Screening mammography is still recognized as the most effective tool available for the early detection of breast cancer,” said Cindy Miller, director of imaging services. “And according to a recent landmark study, digital mammography offers significant benefits to certain groups of women.”

Digital mammography, a mammogram that uses new detection technologies and computers instead of film, was found in a landmark clinical study of more than 42,000 women to be better than film-screen mammography in detecting breast cancer in three groups: women under 50, pre- and peri-menopausal women, and women with dense breasts. Digital mammograms are 15 percent more accurate among women under age 50 or not yet in menopause, and 11 percent more accurate among women with dense breasts.

From the patient’s perspective, the procedure for a digital mammogram is the same as for a conventional film mammogram; however, since the images are available almost immediately and no film development time is necessary, the wait time for the patient is less.

Furthermore, MMHS also uses Fuji’s Synapse® PACS, or Picture Archiving and Communication System, which enables the digital mammograms to be electronically viewed, transmitted and stored. Synapse enables the interpreting physician to use digital tools to electronically enhance and magnify the images, and to adjust the contrast to better examine any suspicious areas. This reduces the need for the patient to be called

back for additional exposures. The PACS also facilitates long-distance consultations with other specialists since the digital images easily can be transmitted to other facilities. They also can be transferred to a CD if a patient needs to take them to another facility.

“The benefits we are experiencing with Fuji’s digital mammography are not only allowing us to do our jobs more effectively and efficiently but, more importantly, they are enabling us to provide the top level of care for our breast imaging patients,” Miller said. “Fuji’s Computed Radiography for Mammography is the most widely used digital mammography system in the world, and we’re pleased to be among one of the first facilities in the U.S. to offer its benefits.”

According to the American Cancer Society, breast cancer is the leading cause of cancer death in women between the ages of 15 and 54.



HOSPITAL RECEIVES GOVERNOR'S AWARD

Mercy Memorial Hospital System received the MPRO 2006 Governor's Award for Improving Patient Safety and Quality of Care in the Hospital Setting. MMHS received the accolade for the Surgical Care Improvement Project (SCIP).

"Award recipients are committed to providing Michigan citizens with high quality healthcare," Governor Jennifer M. Granholm said. "The award is testament to the dedication of these hospitals that give patients the quality care they need and deserve each and every time."

The Governor's Award is based on clinical data for the 2006 calendar year. While the Governor and MPRO have partnered to honor hospitals since 2003, this marks the first time that the Governor has recognized the very top performing Michigan hospitals in the areas related to the Governor's Award for Improving Patient Safety and the Quality of Care in the Hospital Setting and Critical Access Hospital Setting.

Award criteria align with improving care in a number of clinical

areas. MMHS chose from pre-selected clinical areas.

These clinical areas are designated as national healthcare priorities by the Centers for Medicare & Medicaid Services.

Acute Care hospitals individually selected from one or more of the following areas:

- Appropriate Care Measure (ACM) Award
- Surgical Care Improvement Project (SCIP) Award
- AV Fistula Award
- Systems Improvement – Health Information Technology (HIT) Award

MMHS established a multidisciplinary team to spearhead improvement measures using proven, evidence-based practices.

"Together, our staff is demonstrating that we are providing the very best in medical treatment and care — the right care, each and every time," said MMHS spokesperson Barry McDonald. "Our efforts have been enhanced through our collaborations with MPRO, Michigan's Medicare Quality Improvement Organization."

A pilot program with Imaging has begun. Nursing and other departments are scheduled to start soon. Within a year, all services that touch patients at MMHS will have been through the process. We already are receiving higher patient satisfaction scores with the new Imaging program and look forward to similar improvements in other departments in the near future.

Rape Crisis program offers support for victims

Mercy Memorial Hospital System recently started a grant-funded Rape Crisis Center. The Rape Crisis Center provides trained victim advocates to create an environment that systematically advances the care and advocacy of individuals who have experienced violence, specifically sexual assault.

The Rape Crisis Center offers 24-hour advocacy services for survivors of sexual assault and/or friends or family; accompaniment to hospital, law

enforcement agency and/or court hearings; advocacy, support referrals, education; victim crime compensation completion; counseling; and community education on rape prevention. The 24-hour hotline for the center is (734) 240-8800.

"As a hospital, we have an obligation to educate the public that there is help out there, they just need to pick up the phone and call," said Melodie Brooks, director of the Rape Crisis Center.

GRANT FUNDS FREE MAMMOGRAMS

Mercy Memorial Hospital System has been awarded a Susan G. Komen For the Cure grant, which will be used to fund a program for free mammograms for Monroe County women.

The grant money is for the balance of 2007 and ends March 31, 2008. The \$38,826 grant will be used to fund "Put Yourself First Today!" a free mammogram program for Monroe County women. Women are eligible for the program if they are

Monroe County residents, 40 and older (women under 40 need a physician order), and uninsured or underinsured with a demonstrated financial need.

Women who qualify for a free mammogram through the grant-funded program should call (734) 240-8440 to complete the pre-screening process.

MMHS partners with Monroe Cancer Connection to transport any "Put Yourself First Today!" patient to and from her appointment, if necessary.

ECONOMIC IMPACT

The imperative to retain and expand the services provided by our locally controlled, award-winning community hospital is clear from a healthcare perspective. Equally important is the positive economic impact this venture will provide to Monroe and the surrounding communities.

To meet the needs of our changing community, we need to ensure our future. The board and administrative leadership of Mercy Memorial Hospital System have developed an ambitious and comprehensive strategic plan to improve and expand its facilities.

When completed, the important modernization of our emergency and surgery departments, state-of-the-art technology, and private patient rooms will enable MMHS to compare favorably with hospitals in much larger cities. The availability of highly advanced healthcare within minutes of any local community also will help to attract new business and residents.

• **Employment growth:** These improvements will help us fulfill our commitment to the community of being “an accessible community hospital system respected for our quality and known for friendly, personalized care that is close to home.”

As one of the largest employers in Monroe County, we will continue to provide quality job opportunities to more than 1,600 community members and increase our employment numbers by nearly 400 employees.



INCREASING MARKET SHARE

While MMHS treats 65 percent of the inpatient cases in and around the city of Monroe, another 20 percent travel to Toledo to receive “high end” care. Additionally, many patients in the western portion of the county travel to Ypsilanti and Ann Arbor for advanced treatment. Increasing inpatient and outpatient volumes translate into annual revenue growth. The net result is an estimated \$24.5 million increase in annual revenue from inside and outside Monroe County.

INVESTMENT

The anticipated investment of this project will be in excess of \$60 million. This project has been reviewed and is supported by the prestigious Standard & Poor's and Moody's organizations, leading to approval by the Monroe Hospital Finance Authority to initiate a \$49 million bond offering to fund vital enhancements. - **Emergency Department:** The emergency department currently manages more than 40,000 visits per year in a facility designed to accommodate 25,000 visits. The new emergency center will be able to accommodate up to 60,000 visits and improve patient service in a comfortable private setting.
- **Surgery Department:** The surgery department, last upgraded more than 20 years ago, will be designed to support the latest in advanced inpatient and outpatient surgical procedures. On the first floor, the surgical teams will have immediate access to the latest diagnostic technology. The location alone will maximize efficiency and improve patient care by minimizing transport. The expanded waiting and recovery areas will provide greater patient and visitor comfort while enabling the hospital to perform high-end procedures.
- **Imaging Department:** An updated radiology suite will include

the latest in diagnostic technology, including a 64-slice CT Scanner, a powerful fixed magnetic resonance scanner and digital imaging technology. Along with a new cardiac catheterization/special procedures suite, these advancements will improve Mercy Memorial Hospital System's ability to recruit and train healthcare staff to treat inpatient needs.

CHARITABLE CONTRIBUTIONS

We are also seeking to obtain \$15 million in charitable contributions. This will help fund other projects such as:

- **Private rooms:** A new patient tower will add 12 larger rooms and provide additional space to allow the hospital to gradually convert to all private rooms. The net effect will not be more licensed beds, but more space and privacy.

TRANSFORMING AN IMAGE

MMHS must transform itself to increase capacity; this includes advanced cardiac and vascular testing and treatment, larger operating rooms, increased acquisition of state-of-the-art technology, the offering of private rooms and efficient patient and information flow.

- **Financial status:** With a strong balance sheet, it is critical that we transform our health system to reverse the recent trend of disappointing operating margins.
- **Maintain independence:** MMHS is one of six remaining independent, private, not-for-profit community hospitals in southeast Michigan. Our value of independence translates into local governance to control the local assets. While we may align with other providers to offer high quality services locally, it will be the local governance that will determine who we work with for what services.

In order to maintain a strong economic position for the foreseeable future, the transformation must start now. Any financial assistance Mercy Memorial Hospital System receives is not only an investment in the health and economic strength of the community, but it also sends a clear message that our community intends to keep its healthcare asset independent.

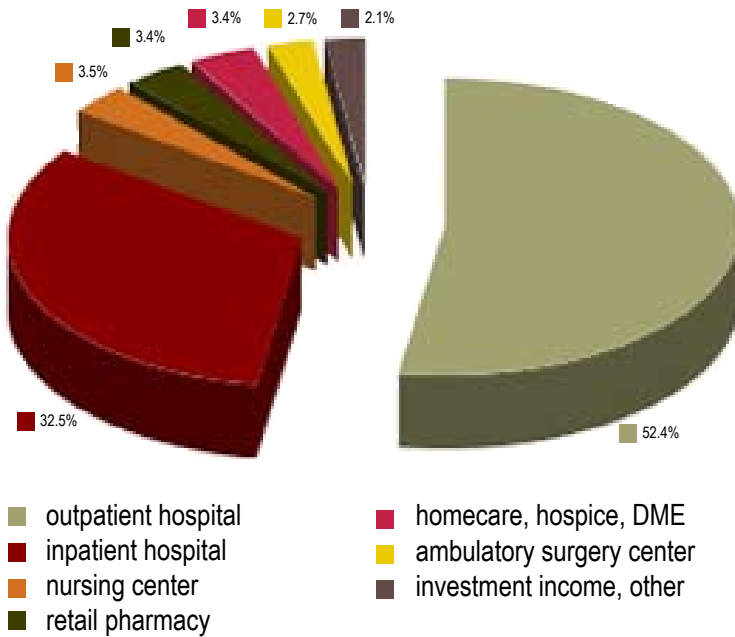

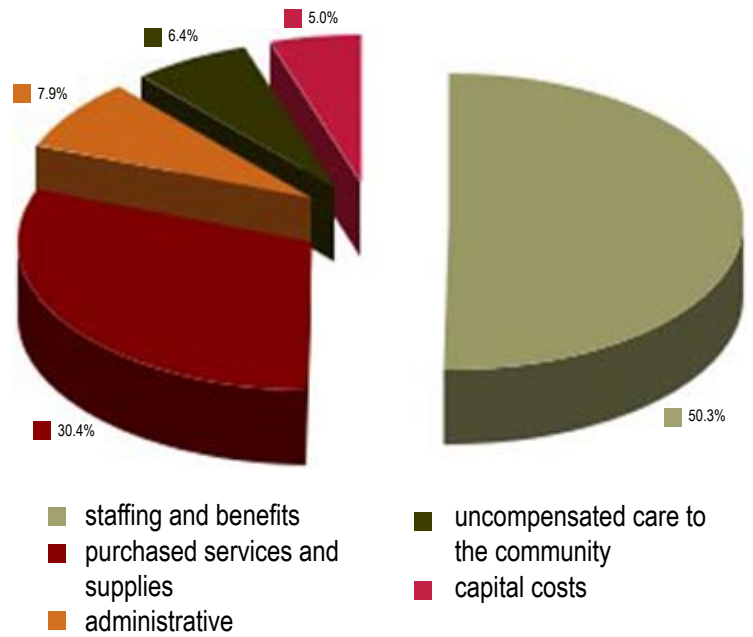

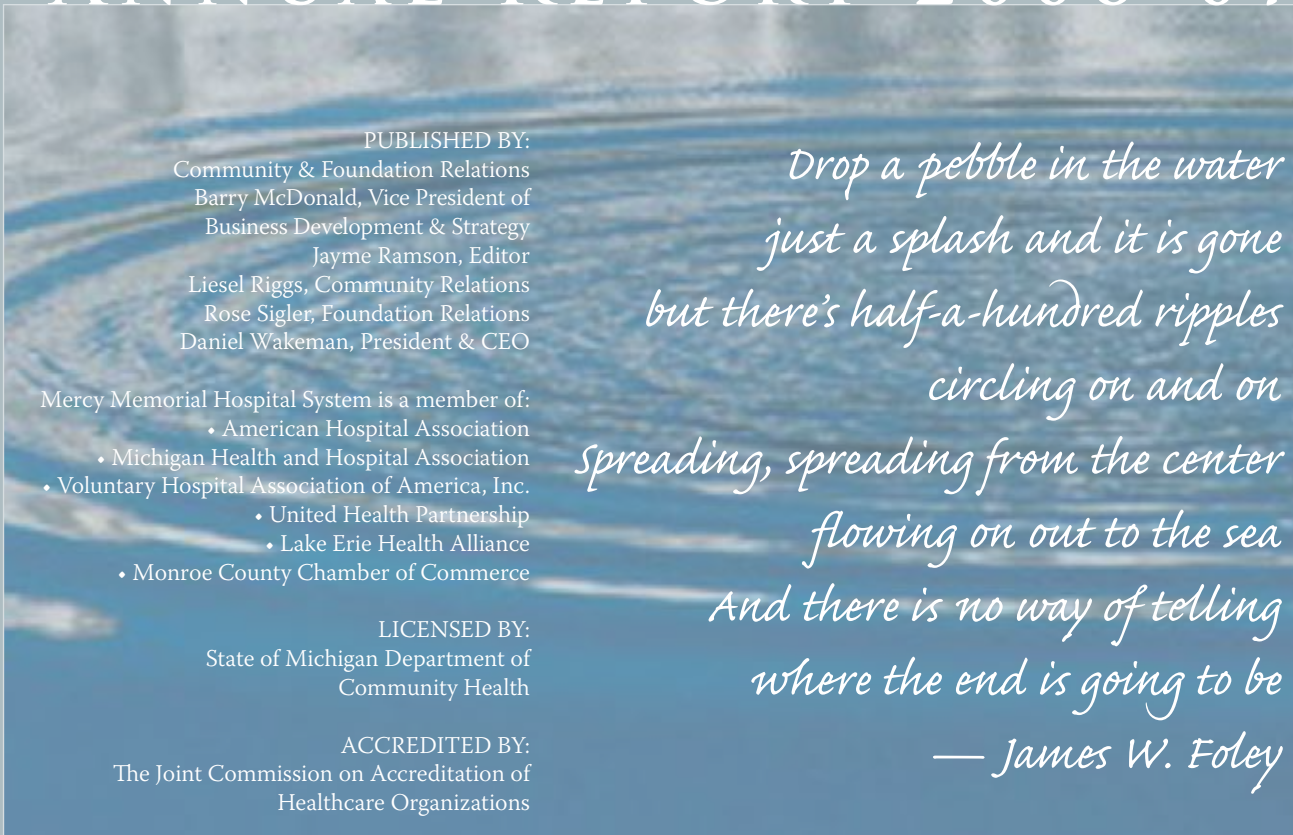
