The purposes of this modification are the following:

A. To exercise FAR Clause 52.217-8; as a result the contract is revised to reflect the following:

1) Period of Performance

(a) The period of performance is extended by 4 months to January 25, 2012. Therefore, the period of performance is changed to read September 26, 2011 to January 25, 2012.

2) Ceiling Increase

(c) To increase the estimated ceiling from \$4,233,839.09 by \$580,426.93 to \$4,814,266.02.
