**Please note that we removed License Condition No. 11. B as it appeared in Amendment No. 05 of your NRC Material License. Due to an NRC policy change, you will not be able to change and name your Radiation Safety Officer (RSO) internally as Condition No. 11. B previously allowed. NRC must do that for you via the amendment process.**

**For future RSO changes please submit the name of the proposed RSO, his/her training and experience qualifications, a statement signed and dated by the proposed RSO that s/he accepts the position as RSO, and that s/he understands the duties, and responsibilities associated with the RSO position.**


In accordance with 10 Code of Federal Regulations 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.
