SUBJECT: NOTIFICATION OF THE ISSUANCE OF THE DRAFT ENVIRONMENTAL  
IMPACT STATEMENT FOR THE FERMI UNIT 3 COMBINED LICENSE  
APPLICATION REVIEW

Dear Mr. Dennis V. Kequom:

The U.S. Nuclear Regulatory Commission (NRC) is reviewing an application submitted by the Detroit Edison Company for a combined license (COL) for construction and operation of a new nuclear power plant, Fermi Unit 3, at its Enrico Fermi Atomic Power Plant site in Monroe County, Michigan. As part of its review of the proposed action, the NRC staff has prepared a draft environmental impact statement (EIS). The U.S. Army Corps of Engineers, Detroit District (USACE), is a cooperating agency on the draft EIS.

In our letter dated December 24, 2008, the NRC described the proposed action and invited your tribe to provide any comments or identify any concerns or issues related to the licensing action that should be addressed in the draft EIS. This scoping letter also indicated that, in accordance with Title 36 of the Code of Federal Regulations (36 CFR) 800.8(c), the NRC staff is using the process required by the National Environmental Policy Act for the preparation of the EIS to comply with the obligations imposed under Section 106 of the National Historic Preservation Act of 1966, as amended (NHPA), in lieu of the procedures set forth in 36 CFR 800.3 through 800.6.

Through this letter, the NRC and USACE staff are forwarding the draft EIS to you for your review and comment. The draft EIS includes analyses of relevant environmental issues, including potential impacts and effects on historic properties, and documents the NRC staff's determination regarding the suitability of the proposed site for the construction and operation of a new nuclear unit. We will address your comments in the final EIS, thus completing consultation under Section 106 of the NHPA for the Fermi Unit 3 COL application.

The NRC and USACE plan to hold two public meetings to go over the analysis and results in the draft EIS on Thursday, December 15, 2011, at Monroe County Community College, La-Z Boy Center Meyer Theater, 1555 South Raisinville Road, Monroe, Michigan 48161. The first meeting will convene at 1:00 p.m. and will continue until 4:00 p.m., as necessary. The second meeting will convene at 7:00 p.m., with a repeat of the overview portions of the first meeting, and will continue until 10:00 p.m., as necessary. The meetings will be transcribed and will include: (1) a presentation of the contents of the draft EIS; and (2) the opportunity for interested government agencies, organizations, and individuals to provide comments on the draft report.
