Dear Mr. Davis:

NRC Generic Letter 89-13, "Service Water System Problems Affecting Safety-Related Equipment," recommended actions we should take to assure that our service water systems are in compliance with certain specified requirements of 10 CFR 50, Appendix A and Appendix B. The Generic Letter also requested that we advise you that we have established a program that will implement these recommendations or have taken an equally effective course of action.

The purpose of this letter is to inform you that we have taken steps to implement the recommendations of Generic Letter 89-13. However, many of the initial activities (*e.g.*, inspections, heat exchanger tests) can be completed only when the DAEC is shutdown. Therefore, we will complete our initial activities prior to startup from our next refueling outage. This schedule was reported to you in the referenced letter. As required by the Generic Letter, we will inform you of the completion of our initial activities within 30 days after startup from this outage. On-going activities will be performed as required during subsequent refueling outages.

Documents associated with the actions we have taken in response to this Generic Letter are on file and will be made available upon request.
