This is in reference to your letter dated September 19, 2011 requesting to amend Nuclear Regulatory Commission License No. 06-23364-01. In order to continue our review, we need the following additional information:

1. As stated in NUREG-1757, Volume 1, Rev 2, "Consolidated Decommissioning Guidance Decommissioning Process for Materials Licensees," for all sealed sources, including those no longer in licensee's possession, provide the results from the most recent leak tests demonstrating there has been no leakage.
2. Please complete NRC Form 314, "Certificate of Disposition of Materials (enclosed) or provide equivalent information.
