

Re: Subrie Abedallhadi, M.D.

During his cardiology fellowship at St. Joseph's Regional Medical Center affiliated with Seton Hall University, Dr. Subrie Abedallhadi completed 6 months of training in Nuclear Cardiology. He performed 575 perfusion studies and was involved in the interpretation of approximately over 150 radionuclide ventriculograms. Including didactic sessions involving case presentations, Dr. Subrie Abedallhadi received approximately over 1000 hours of training in Nuclear Cardiology. He participated in all aspects of the Nuclear Cardiology laboratory which includes 500 hours of supervised work experienced consisting of: A) ordering, receiving and unpacking radioactive materials safety and performing related radiation surveys. B) Calibrating dose calibrators and performing checks for proper operation of survey meters. C) Calculating and safely preparing patient dosages. D) Using administrative controls to prevent misadministration of radioactive materials. E) Using emergency procedures to contain spilled radioactive materials safely and proper decontamination procedure. F) Eluting Technetium - 99m from generator assay.

He also received 500 hours of supervised clinical experience/training consisting of: A) Examining patients and reviewing their case histories to determine suitability for radionuclide diagnosis, limitations or contraindications. B) Selecting the suitable radiopharmaceuticals and calculating dosages. C) Administering dosage to patients and using syringe radiation shields. D) Collaborating with authorized user in interpretation of radionuclide test results. E) Following up on patients.

He performed satisfactorily in his Nuclear Cardiology training program. He meets all of the clinical requirements for reading and performing Nuclear Cardiology studies.


