## 2) Physical Description

This shipment consists of 1 x 20' container loaded with 789 x Gd UO<sub>2</sub> rods packed into 6 x Traveller packages, USA/9297/AF-96 Rev 3. RADIOACTIVE MATERIAL, Type A Package, Fissile. Total net weight of U is 1,686 kgs. The net weight of U-235 is 78 kgs.

## 3) Transportation and Route Schedule

The ocean transportation from Gothenburg, Sweden to the Port of Norfolk, VA will be the responsibility of Atlantic Container Line. The inland transportation from Norfolk, VA to Columbia, SC will be the responsibility of Westinghouse Electric Corporation.


