The purpose of this modification is as follows:

A. To exercise FAR Clause 52.217-8; as a result this task order is changed to reflect the following:

1) Period of Performance

(a) The period of performance is extended by 4 months to January 25, 2012. Therefore, the period of performance is changed to read September 26, 2007 to January 25, 2012.

2) Ceiling Increase

(b) To increase the estimated ceiling from \$668,008.67 by \$58,703.52 to \$726,712.19.

(c) This option is being exercised at the labor rates and the ceiling amount in the attached pricing schedule. The ceiling and rates for Option Year 3 are currently in effect until September 25, 2011. The labor rates and ceiling increase listed above and in the pricing schedule attached take effect on September 26, 2011.

3) Incremental Funding
