The purpose of this modification is to: (1) extend the term of the contract through October 14, 2011, to allow for completion of Task 3.4, "Develop Final Presentation," and (2) increase the obligation amount by \$1,000.00 from \$30,000.00 to \$31,000.00.

Accordingly, the following changes are hereby made:

1. Subsection A.2, entitled, "<u>Consideration and Obligation</u>," is deleted in its entirety and substituted with the following in lieu thereof:

"a. The total estimated amount of this contract for the products/services ordered, delivered, and accepted under this order is **\$33,114.84**. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with contractor during the contract period provided such orders are within any maximum ordering limitation prescribed under this contract."

b. The amount presently obligated with respect to this contract is **\$31,000.00**. The Contracting Officer may issue orders for work up to the amount presently obligated. The obligated amount shall, at no time, exceed the order ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

2. Paragraph 12.0 of the SOW, entitled, "**Period of Performance**," is deleted in its entirety and Substituted with the following in lieu thereof:

"The period of performance of this contract will be September 30, 2010 – September 30, 2011."
