The planning meeting was hosted by Secretary of Treasury Eric □ Beall, James Paulson and was attended by Secretaries and Deputies from most Cabinet level offices such as the Department of Justice, Federal Trade Commission, Department OCM/JM of Homeland Security, and Department of State. The SEDs are focused on US-Droggitis, Spiros China economic relations.
