Submittal of Revision 26 to the Updated Final Safety Analysis Report

In accordance with the requirements of 10 CFR 50.71(e), the FirstEnergy Nuclear Operating Company (FENOC) is hereby submitting to the Nuclear Regulatory Commission (NRC) Revision 26 to the Beaver Valley Power Station (BVPS), Unit No. 1, Updated Final Safety Analysis Report (UFSAR) in CD-ROM format. This submittal reflects facility and procedure changes implemented between May 21, 2009 (the end of Refueling Outage 19) and November 04, 2010 (the end of Refueling Outage 20), along with several changes implemented after Refueling Outage 20.

As requested by NRC guidance for electronic submissions to the Commission, Attachment 1 provides a listing of document components that make up the enclosed CD-ROM. In addition to the UFSAR, the enclosure includes the BVPS Unit No. 1 Licensing Requirements Manual, Revision 73, incorporated by reference in the UFSAR, and the Technical Specification Bases, Revision 15. The Technical Specification Bases are submitted to satisfy Technical Specification 5.5.10.d, which requires submittal of Bases changes implemented without prior NRC approval.

In accordance with 10 CFR 50.54(a), FENOC is hereby submitting a copy of the current revision of the FENOC Quality Assurance Program Manual (QAPM). Revision 15 of the FENOC QAPM is provided in the enclosed CD-ROM.

Attachment 2 includes a summary of information removed from the BVPS Unit No. 1 UFSAR in accordance with Appendix A to Nuclear Energy Institute (NEI) 98-03, "Guidelines for Updating Final Safety Analysis Reports," as endorsed by Regulatory Guide 1.181, "Content of the Updated Final Safety Analysis Report in Accordance with 10 CFR 50.71(e)."

Information Removed from the BVPS Unit No. 1 UFSAR

In accordance with Nuclear Energy Institute (NEI) 98-03, Revision 1, "Guidelines for Updating Final Safety Analysis Reports," licensees are required to periodically report a brief description of information removed from the Updated Final Safety Analysis Report (UFSAR) and the basis for its removal. The following provides a summary of the information removed from the UFSAR and the basis for removal.

1. UFSAR Change Notice 11-020 removed reference to a specific Technical Specification related to fuel oil properties because the Technical Specification was not applicable to the fuel oil in all of the tanks mentioned, and the information was considered excessive detail.
