Subject: NRC Safety Review Status Update

Tekia – Do you know if there are any additional supplemental RAIs in the process at this time? Also, appreciate if you have any status update information in general.

At this time there are no supplemental RAIs in process. Some sections of the review are completing Phase A while others have moved into Phase B. Phase A cannot be considered complete until all sections are complete.

We are interested in understanding how you will be communicating the results of the NRC review schedule evaluation and resulting schedule milestone impacts. Will this be a formal letter to Exelon, and when is this planned to be issued?

Any changes to the Phase milestones will be provided in a formal letter to Exelon. The letter is expected to be sent to Exelon in October 2011. The letter will follow a call from the New Reactors Office Director and possibly a follow up call from the NRC Chairman.

The revised E-Plan documents reflecting the addition of Calhoun County to the 10-mile EPZ will be submitted to the NRC either today or tomorrow as committed in RAI response 13.03-34. We will Federal Express to you your designated cc copy and a courtesy copy once it is signed out. The original, and other cc copies, will be sent via U.S. mail since the submittal transmits a CD containing the electronic files for the documents.
