REVISED TRAVEL ALERT FOR JAPAN (FSME-11-094)

Purpose: To announce the issuance of a October 7, 2011, revised Travel Alert for Japan by the Department Of State (DOS) and the U.S. Nuclear Regulatory Commission's (NRC) position.

Background: During the early stages of the March 2011 Japan event, the NRC recommended to the DOS that U.S. citizens within 50 miles of the Fukushima Daiichi facility evacuate. This conservative recommendation was based on deteriorating conditions at the site and a need to provide advance actions in the face of considerable uncertainty about the outcome of events. The DOS subsequently issued a travel advisory on March 16, 2011, for U.S. citizens to evacuate to 50 miles.

Discussion: With stabilizing conditions at, and around, the Fukushima Daiichi facility, the NRC supports the Government of Japan (GOJ) and the current DOS Travel Alert, which relaxes the existing 50-mile evacuation recommendation. This decision is based on the U.S. Government's assessment of current site conditions as reported by the GOJ.
