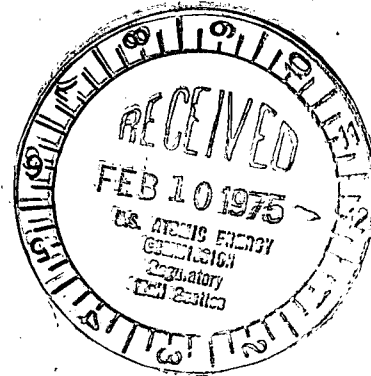

MONTICELLO NUCLEAR GENERATING PLANT
Docket No. 50-263 License No. DPR-22

Contrary to our report of August 30, 1974, concerning RO Bulletin 74-9, the trip roller bars for 4 KV circuit breakers at the Monticello Nuclear Generating Plant have not been replaced during the January 1975 refueling outage. All 4 KV circuit breakers were inspected for trip roller bar clearance during the outage. These inspections revealed that there is no possible source of interference as described in the Bulletin. The circuit breaker manufacturer (General Electric) has concurred with this, explaining that the interference described was with the linkage which actuates the auxiliary switchblock while the breaker is in the test position. The Monticello circuit breakers are not equipped with this linkage.
