Low Boron Concentration in Standby Liquid Control Storage Tank

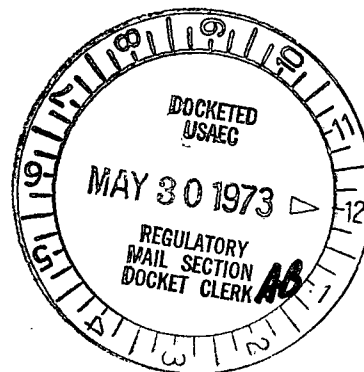
On May 25, 1973, a chemical analysis of the Boron Concentration in the Standby Liquid Control Storage Tank revealed that the concentration was below that required by Technical Specification 3.4.C. The analysis was made following an addition of water to replenish solution lost due to pump seal leakage. The boron concentration is being restored to an acceptable level.
