XXXXX TESTING AT THE NORTHERN STATES POWER COMPANY, MONTICELLO,
MINNESOTA, NUCLEAR GENERATING PLANT. THIS DECISION IGNORES THE
PENDING LITIGATION IN FEDERAL AND STATE COURTS REGARDING
JURISDICTION OF THE XXX THE MINNESOTA POLLUTION CONTROL AGENCY
IN SETTING SAFETY STANDARDS. THIS ORDER ALSO IGNORES THE
SUBSTANTIVE ENVIRONMENTAL PROTECTION ISSUES RAISED BY THE
MINNESOTA ENVIRONMENTAL CONTROL CITIZENS ASSOCIATION. NOTHING
COULD BETTER ILLUSTRATE THE CONFLICT OF INTEREST INHERENT IN
THE AEC'S ATTEMPTS TO REGULATE ITS OWN DEVELOPMENT OF POWER
RESOURCES. THIS ACTION ALSO REPRESENTS THE CONTINUING MISTAKEN
POLICY WHICH SACRIFICES ENVIRONMENTAL PROTECTION AND CITIZEN
RIGHTS OF PARTICIPATION TO IMAGINED ECONOMIC EXIGENCIES.
