

RESOLVED, That the Council of the City of Salat Paul, on bahalf of the City of Salat Paul, its citizens and consumers of the water supply supplied by its W her Department, does hereby concur in the actions taken by the Beard of Water Coundesioners of the City of Salat Paul, and does hereby respectfully request the Atomic Safety and Licensing Beard, United States Atomic Energy Councilsion, to damy the provisional operating license for fuel loading and low-power start-up testing of the Northern States Power Company's Hemilesile Nuclear Generating Plant, Unit No. 1)

The Council of the City of Saint Paul believes that this plant chould not be allered to sporate values and until Northern States Power Company makes providion for complete off-site disposal of all radioactive liquide, measure and solid wastes.
