Coley:

The technical staff has reviewed the draft slides in preparation for the Oct 4th ACRS meeting and have the following questions:

Slide no. 9:

Second sub bullet states that suppression pool temperature reaches 77°C in approximately 6 hours. However, a sub bullet under it notes that RCIC will continue to operate for approximately 8 hours. What is the significant of 8 hours? Does the NPSH margin become zero at 8 hours?

Slide no. 10:

Bullet no. 2 states that SP temperature > \sim 275°F, \sim 16 hours and NPSH may be lost \sim 32 hours. If the suppression pool temperate exceeds 275°F in 16 hours, NPSH margin will be lost. What is meant by NPSH may be lost \sim 32 hours.

Slide no. 12 (backup info.):

What is the basis for 77°C? If it is the lube oil viscosity, why not state that in slide 10, which states that RCIC turbine-pump bearings are rated to 250°F (~ 12 hours) (bullet 3)?

I realize its last minute but if possible could we have a quick call to discuss these questions prior to the ACRS meeting (tomorrow or Monday)?
