As discussed in our recent telephone conversation, every effort will be made to complete the necessary actions so that our Monticello Plant Operating License Application can be considered by ACRS at its December meeting. Construction of the plant is progressing well and we are scheduling fuel loading for March 1, 1970, and in fact there is some possibility that we can better this fuel load date. We are scheduling substantial overtime to maintain this construction schedule consistent with a December ACRS meeting.

Members of your staff visited the site on September 17 and were here in our offices for a meeting the following day. The inspection trip and the meeting provided effective communications on several matters that must be clarified in order to complete our Monticello application. To expedite the completion of our application, we are planning to meet with members of your staff on October 2 and 3. We would like to hold additional meetings during subsequent weeks with the objective of supplying all of the required application information prior to November 1. This arrangement, we understand, will complete the record with the required lead time prior to the ACRS meeting.

I appreciate your continued cooperation in helping us to obtain the Monticello operating license for a March 1, 1970 fuel loading.
