

License Amendment Request Dated February 15, 1983  
Instrumentation Setpoint, Turbine Bypass Valve and  
Miscellaneous Technical Specification Changes

Attached are 3 originals and 37 conformed copies of a request for a change in the Technical Specifications, Appendix A, of Operating License DPR-22. Also attached is one copy of the license amendment class determination and a check in the amount of \$5,200.00 for the amendment fee.

The proposed changes would revise or add new Limiting Conditions for Operation and Surveillance Requirements for Reactor Protection System Power Monitoring System Setpoints, Turbine Bypass Valve and Feedwater/Turbine Trip on high reactor water level instrumentation. Also included are miscellaneous proposed changes intended to correct or clarify certain sections of the Technical Specifications.

Exhibit A contains the proposed changes, reasons for change, and safety evaluations. Exhibit B contains revised Appendix A pages showing the proposed changes.
