SUBJECT: EMERGENCY RESPONSE CAPABILITY -
CONFORMANCE TO REG GUIDE 1.97, REV. 2

Re: Monticello Nuclear Generating Plant

We have completed our preliminary review of your submittal dated December 30, 1983. We have concluded that you have provided an explicit commitment on conformance to Reg Guide 1.97 with the exception of certain items which you have identified. We have also concluded that your justification for exceptions to Reg Guide 1.97 for some items is acceptable. However, there are some items for which we could not conclude that adequate justification was provided. Those items are identified in the interim report which is enclosed with this letter.

You should respond to those open items within 60 days from the date of receipt of this letter. You should also provide any other comments regarding incorrect assumption or misunderstood commitments. Following resolution of the open items a Safety Evaluation will be provided to complete this action.

The reporting and/or recordkeeping requirements contained in this letter affect fewer than ten respondents; therefore, OMB clearance is not required under P.L. 96-511.
