License Amendment Request Dated February 14, 1986
Change in Expiration Date of Operating License

Attached are three originals and 37 conformed copies of a request for a change in the Operating License for the Monticello Nuclear Generating Plant. This request is submitted in accordance with the provisions of 10 CFR Part 50, Section 50.90. A check is attached in the amount of \$150.00 in accordance with the requirements of 10 CFR Part 170 for the amendment application fee.

The proposed change will revise the expiration date of the Monticello Operating License from June 19, 2007 to September 8, 2010. In accordance with current Nuclear Regulation Commission policy, this establishes the period of the Operating License as 40 years from date of issuance. The Operating License currently specifies an expiration date based on 40 years from date of the Monticello Construction Permit.

Exhibit A contains a description of the proposed change, the reasons for requesting the change, a Significant Hazards Determination, and an assessment of environmental impact. Exhibit B contains pages of the Monticello Operating License with the requested wording changes.
