Correction of Revision No. 1 to License Amendment Request
Dated September 14, 1984, Minimum Shift Crew Composition

On January 10, 1986 we submitted a revision to our License Amendment Request dated September 14, 1984. This revision consisted of one page and was intended to correct an oversight in the draft Table 6.1.1, "Minimum Shift Crew Composition," contained in the original submittal.

In conversations with the Monticello technical staff, NRC reviewers for this change, and the Monticello Project Manager in NRC BWR Project Directorate #1, it appears that two additional corrections should be made to this table. The corrected table is attached.

We believe that the corrections to the table are relatively minor in nature and do not affect the intent of the original submittal or the content and conclusion of the original significant hazards determination. The first correction increases line three of the table by one. All three of the first line entries should reflect an increase of one. The second correction adds a clarification note that the plant staff finds desirable.
