License Amendment Request Dated October 3, 1986
Additional Source of Offsite Power

Attached are three originals and 37 conformed copies of a request for a change in the Technical Specifications, Appendix A of the Operating License, for the Monticello Nuclear Generating Plant. This request is submitted in accordance with the provisions of 10 CFR Part 50, Section 50.90. A check is attached in the amount of \$150.00 in accordance with the requirements of 10 CFR Part 170 for the amendment application fee.

During the 1986 refueling and maintenance outage, a modification was made to the plant to provide another source of offsite power. No. 11 auxiliary transformer, which was powered from the main generator, was removed. A new transformer, No. 2R, was installed. No. 2R transformer is powered from the 345KV substation instead of the main generator. This represents an additional immediate access source of offsite power to the plant, bringing the total number of such sources to three. The proposed changes to the Monticello Technical Specifications reflect this additional offsite source.

Exhibit A contains a description of the proposed changes, the reasons for requesting the changes, and a Significant Hazards Determination. Exhibit B contains pages of the Monticello Technical Specifications revised to show the proposed changes.


