License Amendment Request Dated October 21, 1991  
Reactor Feedwater Pump Trip Instrumentation

Attached is a request for a change in the Technical Specifications, Appendix A of the Operating License for the Monticello Nuclear Generating Plant. This request is submitted in accordance with the provisions of 10 CFR Part 50, Section 50.90.

We committed to revising the Technical Specification to include requirements to periodically verify the operability of the reactor feedwater pump trip in our response to Generic Letter 89-19, dated May 4, 1990 regarding overflow protection. This amendment adds limiting conditions for operation and surveillance requirements for the reactor feedwater pump trip instrumentation to the Technical Specifications.

Exhibit A contains a description of the proposed changes, the reasons for requesting the changes, and a Safety Evaluation/Determination of Significant Hazards Consideration. Exhibit B contains the Technical Specification pages marked up with the proposed wording changes. Exhibit C contains revised Monticello Technical Specification pages.
