We committed to revising the Technical Specification to include requirements to periodically verify the operability of the reactor feedwater pump trip in our response to Generic Letter 89-19, dated May 4, 1990 regarding overfill protection. This amendment adds limiting conditions for operation and surveillance requirements for the reactor feedwater pump trip instrumentation to the Technical Specifications.
