By references 1 through 11 above, FPL submitted correspondence to register the initial use of spent fuel ISFSI casks pursuant to 10 CFR 72.212(b)(1)(ii). Subsequently, FPL discovered that all relevant registration information was not included; a more complete description would include both the horizontal storage modules (HSMs) and the dry storage casks (DSCs). The original information did not include the unique identifier for the DSCs. This letter cross references the registration letters (references 1 – 12 above), the associated HSMs registered, and provides the supplemental DSC information.
