Status of Fire Protection Actions

Ref (a): Letter dated July 7, 1978 from L O Mayer, NSP, to Director of Nuclear Reactor Regulation, "Status of Fire Protection Actions".

Reference (a) stated that extension of the turbine lube oil reservoir deluge system would be completed prior to startup following the Fall 1978 refueling outage. We find we are unable to meet that schedule. The design of the deluge system extension has been completed. Following field verification of the design and review by our insurance department, installation will commence. The design will permit installation of the extension during normal plant operation. It is anticipated that this project will be completed by January 31, 1979.

This item was discussed with our NRC Region III inspector on November 13, 1978.
