Licensed Operator Requalification Program

Mr P F Collins' letter dated December 28, 1976 granted approval to the revised Monticello Operator Requalification Program that was submitted October 15, 1976 (Revision 4), but subject to a wording revision in Section 3.F, item 8. Revision 5 (dated 12/28/76) to the Monticello Operator Requalification Program was issued to incorporate the NRC wording and was transmitted Mr Victor Stello, Director, Division of Operating Reactors on January 4, 1977. The Monticello operator requalification program has been conducted in accordance with Revision 5.

In Attachment 4 of the letter from J A Gonyeau (NSP) to the Director of Nuclear Reactor Regulation, dated August 1, 1980, a revised licensed operator requalification program was submitted to the NRC in response to Lessons Learned requirements. NRC regulation 10 CFR 50.54(i-1) allows the licensee to make changes in an approved operator requalification program if the scope, time allotted for the program or frequency in conducting different parts of the program is not decreased. We have reviewed the Licensed Operator Requalification Program contained in Attachment 4 of the August 1, 1980 submittal with Revision 5 of NSP's approved Licensed Operator Requalification Program. We have concluded that the August 1, 1980 Licensed Operator Requalification Program does not decrease the scope, time allotted for the program or frequency in conducting different parts of the program. Therefore, it is our intent to adopt the August 1, 1980 Licensed Operator Requalification Program (copy enclosed) for use effective December 15, 1981, replacing Revision 5.
