NRC Request for Additional Ínformation Related to Environmental Qualification of Safety-Related Electrical Equipment

In a letter dated January 26, 1982 from Domenic B Vassallo, Chief, Operating Reactors Branch #2, Division of Licensing, USNRC, we were requested to provide certain information from our environmental qualification central file for review by the Franklin Research Center.

A review of the attachment to Mr Vassallo's letter indicates that our November 16, 1981 submittal was not reviewed by Franklin Research Center prior to preparing their list of required information. Conversations between our consultant, EDS Nuclear, and Franklin Research Center have confirmed this fact. Since our November 16, 1981 submittal is our primary document responding to the NRC Staff's Equipment Qualification Safety Evaluation Report (superseding our September 28, 1981 report in its entirety), we believe it is premature to provide detailed qualification information until this report has been received and reviewed by the Franklin Research Center.

Based on these circumstances, we believe no response to Mr Vassallo's January 26, 1982 request is needed. We will await Franklin's review of our November 16, 1981 report and supply any requested qualification doumentation following that review.
