Changes in Monticello Plant On-Site  
Operating Group Organization

The following information related to recent changes in the Monticello on-site operating group organization is provided for the information of the NRC Staff.

Effective September 1, 1983 Mr D E Nevinski was promoted to the position of Plant Superintendent, Engineering and Radiation Protection (PSERP). Mr Nevinski replaced Mr Morgan H Clarity who was promoted to the new position of Assistant to the Plant Manager. Technical Specification Figure 6.1.2 will be revised to reflect this new position with the next License Amendment Request involving Section 6 of the Technical Specifications. Prior NRC approval of this change is not needed since the minimum functional organization for operation was not affected by this change.

The Monticello PSERP is a key supervisor requiring a current Senior Reactor Operator (SRO) license. Mr Nevinski previously held an SRO license at Monticello before accepting a temporary assignment to the Institute of Nuclear Power Operations in Atlanta, Georgia. Until he is re-licensed as an SRO, Mr Nevinski will contact at least one other individual currently holding an SRO license on matters relating to the Technical Specifications. These individuals typically would be members of the Monticello Operations Committee, thus representing plant management.

We believe the above described procedure will satisfy existing Technical Specification requirements related to the position of PSERP. Please contact us if you have any questions relating to this matter.
