

Supplement 1 to NUREG-0737 - Generic Letter 82-33

Our letter of April 15, 1983 included proposed schedules for implementation of requirements set out in the subject letter. A site meeting was held on July 20, 1983 with Ms Helen Nicolaras, the Monticello Project Manager, to further refine schedule commitments in preparation for the Confirmatory Order.

As discussed in the meeting additional time was requested for submission of the program plan for the Control Room Design Review (CRDR) which will now be submitted by December 31, 1983. Similarly the Procedures Generation Package for the Emergency Operating Procedures (EOP) will now be submitted by July 31, 1984.

This information confirms our telephone conversation with Ms Nicolaras on November 9, 1983.
