Generic Implications of Salem ATWS Events
(Generic Letter 83-28)

In our letter of November 4, 1983 we committed to submit the results of test and maintenance procedure review, technical specification review, and the results of a check of vendor and engineering recommendations. In our letter dated January 11, 1984 we requested an extension to submit these results prior to Cycle 11 Startup.

The review of test and maintenance procedures and technical specifications and the check of vendor and engineering recommendation prescribed in NRC position 3.1.1 and 3.1.2 of the enclosure to Generic Letter 83-28 (Salem ATWS Events) has been completed. Existing post maintenance testing guidance and requirements were found to be appropriate and adequate. No additional requirements were identified.
