Inspection and Testing Program and Requests for Relief from  
ASME Code Section XI Requirements

Attached you will find 40 copies of Revision 5 to our report entitled, "ASME Code Section XI Inservice Inspection and Testing Program". This is a revision of our inservice inspection and testing program description and requests for relief submitted to the Commission on March 27, 1981.

NRC Staff review and approval is being requested for one new Request for Relief (No. 66). The following additional changes are being made to the program manual:

- Components of the newly installed containment combustible gas control system are being added.
- Components added or removed from the plant during the recent recirculation piping replacement program are being reflected.
- Editorial corrections for existing program manual pages, including Requests for Relief submitted earlier.

The revised and new Requests for Relief are being submitted for NRC Staff review and approval in accordance with the provisions of 10 CFR Part 50, Section 50.55(g). Attached is a check in the amount of \$150.00 as required by 10 CFR Part 170 for the application fee.
