PURPOSE: To Discuss Uranerz Jane Dough Site and Nuclear Regulatory
Commission Policy on Equivalent Feed

BACKGROUND:

The purpose of this meeting was for Uranerz Energy Corporation (Uranerz) and Nuclear Regulatory Commission (NRC) staff to discuss the Uranerz Jane Dough site and NRC policy on equivalent feed.

The meeting and teleconference started at 8:00 a.m. Eastern time in room T10C01. An opening statement was presented by Ron Linton, NRC. Participants introduced themselves and signed the attendance sheet.

DISCUSSION:

Staff from Uranerz discussed the location of the Jane Dough unit that is adjacent to the Nichols Ranch unit of the Nichols Ranch *in situ* recovery (ISR) Project. The recently discovered ore is thought to be from the same ore trend as that of Nichols Ranch unit and contains approximately 2.9 million pounds of uranium. There is no Bureau of Land Management (BLM) surface ownership; therefore, no BLM Plan of Operations is required. Mineral ownership is both private and federal. The site is not within the Pumpkin Buttes viewshed.

Uranerz has started vegetation sampling, air particulate sampling, baseline surface and groundwater sampling. There are 13 coal bed methane reservoirs within or close to the proposed licensed boundary. The ore bearing sands are hydraulically confined, saturated, and similar to those found at the Nichols Ranch unit. Uranerz does not anticipate constructing a satellite facility on the site. Pregnant and barren lixiviant will be piped from the Jane Dough wellfields to the Nichols Ranch ISR central processing facility that is under construction at the Nichols Ranch unit site.

Uranerz also discussed the deep disposal wells that are required by license condition for the Nichols Ranch ISR Project. Uranerz asked NRC staff about the possibility of installing evaporation ponds, additional above-ground tanks, or other methods for process bleed storage, if one of the disposal wells went off-line, in lieu of installing a second well as a backup. NRC staff indicated that Uranerz may propose any alternatives and apply for a license amendment that will be evaluated by the staff on its merits. Uranerz and NRC staff discussed several alternatives.

At the request of Uranerz staff, NRC staff discussed NRC's policy on equivalent feed and the draft Regulatory Information Summary (RIS) recently published in the *Federal Register*. NRC staff indicated that as written the RIS does not pertain to licensed NRC facilities. NRC staff was asked if a license amendment would be needed for Uranerz to ship uranium loaded resins to a licensed third party for final processing. Participants discussed the bounding conditions related to transportation in the Nichols Ranch Final Supplemental Environmental Impact Statement and the Final Generic Environmental Impact Statement on ISR milling. NRC staff indicated that the Uranerz Safety and Environmental Review Panel should review the need for an amendment and decide if a license amendment is needed or not. Staff suggested the final decision should be discussed with the NRC staff.

PUBLIC DISCUSSION:

There were no members of the public that attended the meeting.
