Perry Nuclear Power Plant Emergency Amendment

On October 17, 2011, the staff issued an emergency amendment, under the provisions of 10 CFR 50.91(a)(5), to Perry Nuclear Power Plant to allow use of a delayed access circuit until December 12, 2011, as one of two required offsite circuits between the offsite transmission network and the onsite Class 1E alternating current electric power distribution system. The amendment temporarily credits the delayed access circuit as satisfying Technical Specifications 3.8.1(a) to permit resumption of normal plant operation.

Southern California Blackout Investigation Team Meeting

On October 18-19, 2011, the staff participated in a North American Electrical Reliability Corporation investigation team meeting related to the September 8, 2011, Southern California/Arizona/Mexico blackout event and San Onofre Nuclear Generating Station (SONGS) dual unit trip. Representative of the North American Electrical Reliability Corporation, Western Electricity Coordinating Council (WECC), Federal Energy Regulatory Commission, and Nuclear Regulatory Commission participated in the meeting held in the WECC offices in Salt Lake City, Utah. The primary objective of this meeting was to develop a precise, accurate sequence of events for the grid disturbance to create a starting point for root cause analysis and to provide the basis for developing computer models to simulate system conditions and evaluate steady state and grid stability conditions. The staff is evaluating the cause and consequences of loss of both SONGS units as a result of the grid perturbation.

Central Europe Nuclear Safety Workshop

On October 9-13, 2011, the Chief, Regulatory Guide Development Branch, Division of Engineering, RES traveled to Prague, Czech Republic to participate in the Central Europe Nuclear Safety Workshop organized by the U.S. Department of Energy. He presented an overview of NRC Research Activities as well as an overview of the agency response to the Fukushima event. (ML112860652). The purpose of the workshop was to promote international collaboration on research activities within the countries of central Europe. Attendees included the U.S. Department of Energy, Argonne National Laboratory, the Electric Power Research Institute, and the International Atomic Energy Agency (IAEA), as well as representatives of the Czech Republic and most Central European countries.

32<sup>nd</sup> Nuclear Safety Standards Committee (NUSSC) Meeting

On October 18-20, 2011, the Director, Division of Engineering, RES traveled to Vienna, Austria to participate as the U.S. delegate to the 32<sup>nd</sup> NUSSC meeting. He presented an overview of the NRC response to the Fukushima event, including the initial response, the work of the Near Term Task Force, and planned activities going forward (ML112860652). The committee reviewed several IAEA safety standards at the draft stage, as well as document preparation profiles of potential future standards and documents currently under development. The committee discussed the implication of recent events in Japan on NUSSC and other IAEA safety standards and addressed general committee business.

RES Publication of Regulatory Guide (RG) 1.159, Rev. 2, "Assuring the Availability of Funds for Decommissioning Nuclear Reactors"

On October 20, 2011, the staff published RG 1.159, Rev. 2. This guide provides guidance to applicants and licensees of nuclear power, research, and test reactors concerning methods acceptable to the staff for complying with the rules regarding the amount of funds available for decommissioning. It also provides guidance on the content and form of the financial assurance mechanisms needed for compliance with the NRC decommissioning regulations.
