We have received and reviewed your letter of August 9, 2011, in response to our June 17, 2011, Inspection Report and Notice of Violation related to your failure to provide training to comply with appropriate Department of Transportation regulations and failure of an employee to survey when exiting a restricted area as required by your license. We have reviewed your letter and find it responsive to the concerns raised in our Notice. We will review the implementation of your corrective actions during a future inspection to determine that full compliance has been achieved and will be maintained.
