In accordance with the Office of Management and Budget (OMB) memorandum (M-11-32), "Accelerating Payments to Small Businesses for Goods and Services," the U.S. Nuclear Regulatory Commission (NRC) has reviewed its process for making payments to small businesses. Our review of current practice indicates that 67 percent of the Agency's payments to small businesses are paid within 15 days or less. In order to reach the goal of reducing all small business payments to within 15 days, the NRC will modify its small business payments process by reducing the current timeframe between steps in the process for verifying and approving small business invoices.

Our plan is to have the new payment process fully implemented by November 7, 2011. During the transition phase, we will be codifying the new payment process into our business procedures; this includes communicating the new requirements to our project managers and contract specialists. In addition, since the NRC accounts payable function is outsourced we will impose the new expectations to our service provider.

The NRC has determined that November 7, 2011, is the most practicable date of deployment in order to ensure that the NRC successfully coordinates within the agency and with our service provider. Once the new payment process for small businesses is implemented, the NRC anticipates being fully compliant with the requirements as outlined in OMB M-11-32. In order to ensure continued success the NRC will develop an agency-level performance metric, which will allow us to monitor and track NRC's performance in paying small business and make adjustments if necessary.
