In accordance with NUREG-0800, Standard Review Plan, Chapter 2.5.2, "Vibratory Ground Motion," and Regulatory Guide (RG) 1.208, "A Performance-Based Approach to Define the Site-Specific Earthquake Ground Motion" please assess the adequacy of the existing EPRI-SOG seismic source model in light of the August 23, 2011 M5.8 Mineral, Virginia earthquake. The earthquake was located in the Central Virginia Seismic Zone, which is modeled by all of the EPR-SOG ESTs except for the Law Engineering Team. Please review the adequacy of each of the ESTs source models that incorporate the earthquake of the size of the Mineral, Virginia, earthquake on August 23, 2011, (including the Law Engineering Team) in terms of the maximum magnitude probability distribution, source geometry, probability of activity, and seismicity rates. In addition, please address the impact on the GMRS.

In addition, please provide your assessment of the ground shaking experienced at NANPP Units 1 and 2 during the August 23, 2011 **M**5.8 Mineral, Virginia earthquake and address the impact on the GMRS from the COL application for NANPP Unit 3.
