On August 13, 2010 the Chief Nuclear Officer (Adam Heflin) of Ameren Corporation paid a "Drop-in" visit to the US Nuclear Regulatory Commission's Executive Director for Operations (Bill Borchardt) and the Deputy Executive Director for Reactor and Preparedness Programs (Martin Virgilio).
