The following information is submitted in response to IE Bulletin 80-17, Supplement 1, Part B.

- Item 1) The system described in the referenced letter will be installed by September 1, 1980, with the exception of one sensor on each main header. The two redundant sensors are expected to be shipped to the site by September 8 1980. The sensors will be installed upon receipt.
- Item 2) A study of potential designs for improving the venting system for the scram discharge volumes has been performed. We plan to install another vent line on both the east and west side discharge volumes. These lines will be independent of the existing vent lines and will discharge to atmosphere. Check valves will be installed in the vent lines to prevent the spread of contamination when the vent valves reopen following a scram reset. Two check valves will be added in parallel in each vent line such that a single check valve failure will not prevent venting. It is anticipated that these modifications will be completed prior to startup, following our 1981 refueling outage. Installation of parallel check valves on the existing vent lines is presently being pursued and will be completed upon receipt of the necessary materials.
